## 6. Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust. Use breathing equipment if fumes or powders are released into the air. Block the leakage if there is no hazard. ### 8.2. Exposure controls
